On the day of 03.03.2016. in the conference rooms of the College of Applied Technical Sciences a meeting of the National Consortium of WamPPPP project was held. When it comes to the financial side of the intermediate report Irina Cenić inspected the supplied documentation and pointed out that there are minor problems with partners who participate in the project for the first time, so they have yet to do all of the paper work right. Noted that she hopes that in future work and with our assistance they will reach desired goal. that and fill the paperwork properly. Noted that the paperwork that needs to be fixed and supplemented is returned.

She pointed out that CATAR sent all the paperwork in Serbian and that they lack supporting documentation in English for example Annex II annex III. A similar situation is with Belgrade's polytechnic, they lack the Annex III. And other local partners also had made few smaller mistakes, they made mistakes that were mostly related to calculating mileage, so they were sent to the website of the international organization Erasmus + where they will receive appropriate mileage. She noted that there were more problems in obtaining the foreign partners documents, only two partners from Bitola and Thessaloniki have sent financial documentation, other foreign partners didn't deliver anything of the financial documentation.

It was concluded that local partners need to deliver the appropriate information within 7 days, and that the coordinator needs to contact the foreign partners and warn them about the obligation for periodic delivering of financial documentation, as it is stated in the partner agreement.
